1. Refer to addenda 3; item 6. Intent is to add new curb and gutter per previously issued addenda all along the entire south side of southern yard where pavement occurs. See attached drawing for clarification.
2. Refer to drawings; sheet 3, west fencing area south of main admin building. Add weep holes as noted on attached drawing for locations.

The following items are recent RFI questions for clarification.

Q1 - Ad # 2 page 2 calls for a INSL 24UL operator to be used however Ad 2 sheet 3 has a HD SL 24UL circled please clarify which it will be.

Answer - Provide and install the indicated HD SL 24UL motor unit.

Q2 - Is Finish paint & primer required of the fence bid 7 and what color & type of finish paint?


Answer - Iron fencing contractor will be required to finish all ornamental iron fencing and gates utilizing the electrostatic process, primer and 2 coats of finish color. Clean and prep all iron gate and fencing materials to received noted finishes. Light tan is the preferred color. Final color to be determined later.

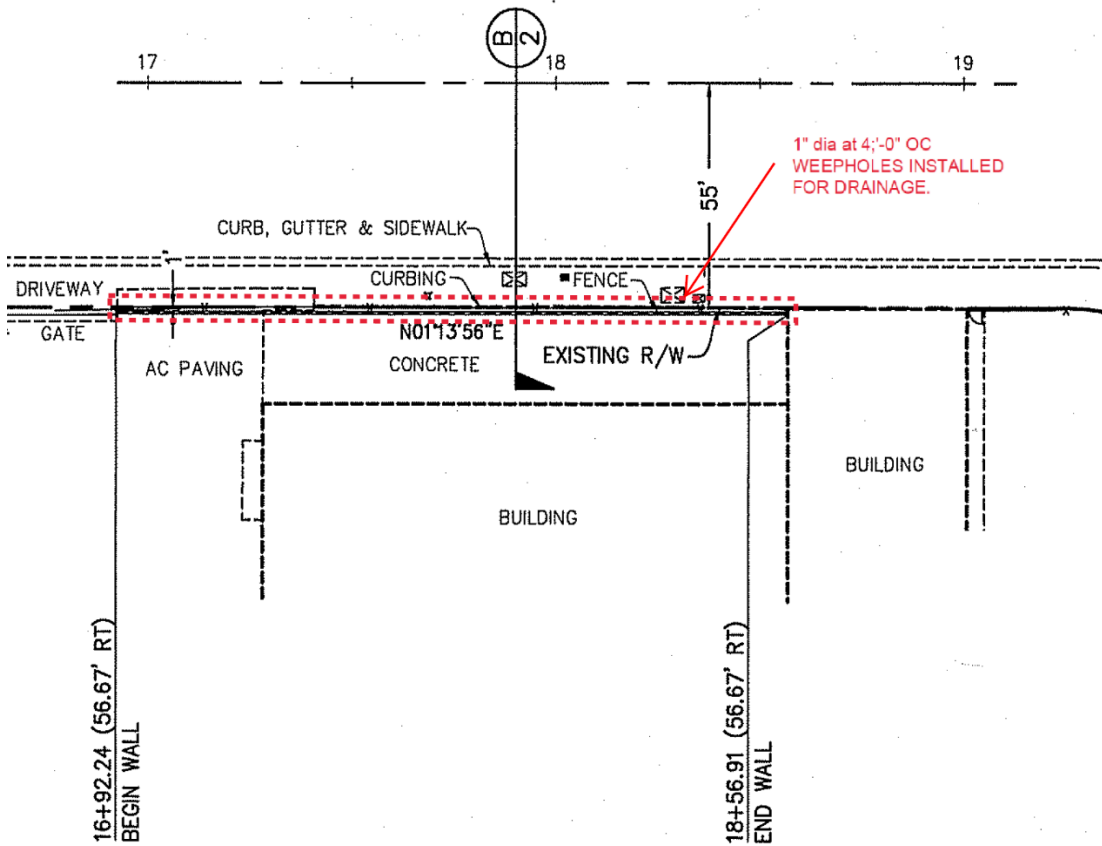

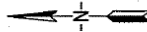

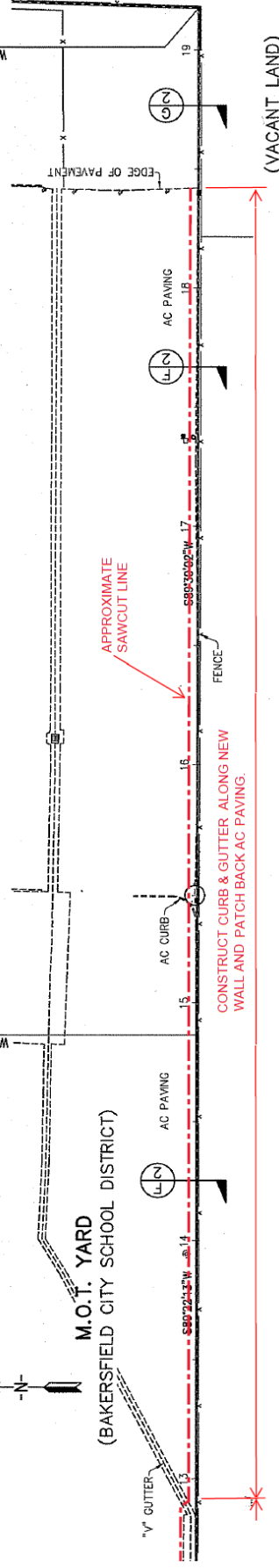


M.O.T. YARD
