ITEM (01) **REFER TO PROJECT MANUAL:** 

- A. Bid Package 01 - Site Demolition, Grading & Concrete:
  - **Refer** to Sheet C1.4 Civil Improvements Grading Plan Middle East Area:
    - a. Provide asphalt saw cutting, removal and dispose of existing asphalt and rough grading at area shown as Grind 0.1' minimum existing AC and overlay to design grades shown on Sheet C1.4.
  - Remove and dispose of asphalt under existing portable classroom buildings to be removed from site by others, prior to site demolition. Remove all steel foundation anchor rods left by portable building moving company.



## **ADDENDUM**

- B. **Bid Package 02** Asphalt and Striping:
  - 1. Provide slurry seal coating at existing basketball court AC Paving. See attached Sheet C1.6 for highlighted area. Include an allowance of \$10,000 to be used for miscellaneous asphalt patching on Time and Material, prior to slurry seal. The \$10,000 allowance shall be included as a separate line item in the payment application schedule of values. Any allowance not used for asphalt patching shall be credited back to the Owner. Court striping will be provided by others.
  - 2. Refer to Sheet C1.4 Civil Improvements Grading Plan Middle East Area
    - **a. Provide** fine grading, base, compaction and new AC paving at area shown as Grind 0.1' minimum existing AC and overlay to design grades shown on Sheet C1.4.
- C. **Bid Package 03** Utilities & Plumbing
  - Provide an underground domestic water gate valve at the existing mater main line point of connection. Provide a ground box set to grade prior to new AC paving. Provide a temporary water line riser with a fire hose connection fitting to be used for temporary construction water. The gate valve and temporary water connection shall be installed during winter break, prior to site demolition.
- D. **Bid Package 04** General Construction:
  - Provide 6' tall chain link fencing around the existing electrical equipment on the north side of classroom building E. Saw-cut or core drill existing asphalt for fence post footings. The chain link enclosure shall be 3 sided - (6'-0" x 8'-0" x 6'-0" with a 3'-0" wide gate).
  - 2. **Provide** (2) barrier rails at existing wall mounted electrical equipment on the south side of existing Building J. Coordinate exact location with Owner. See attached Detail **PH3\_ADD03-A1.**
