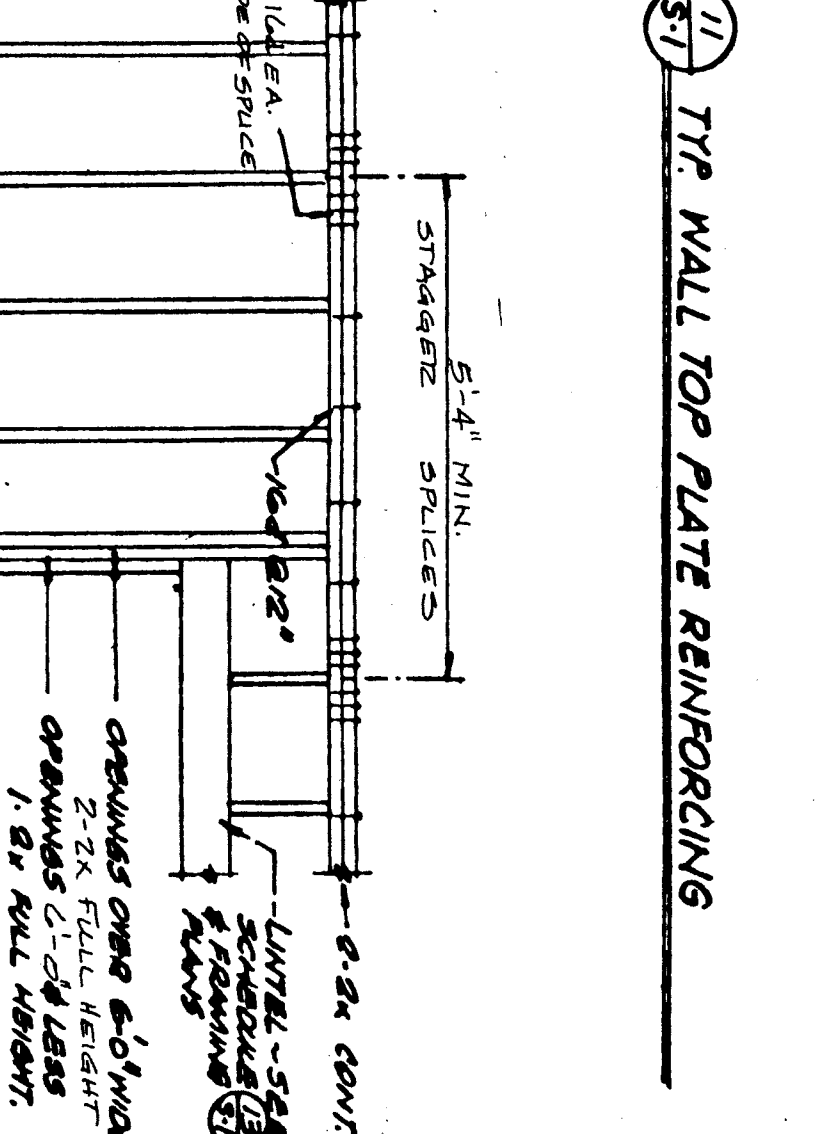
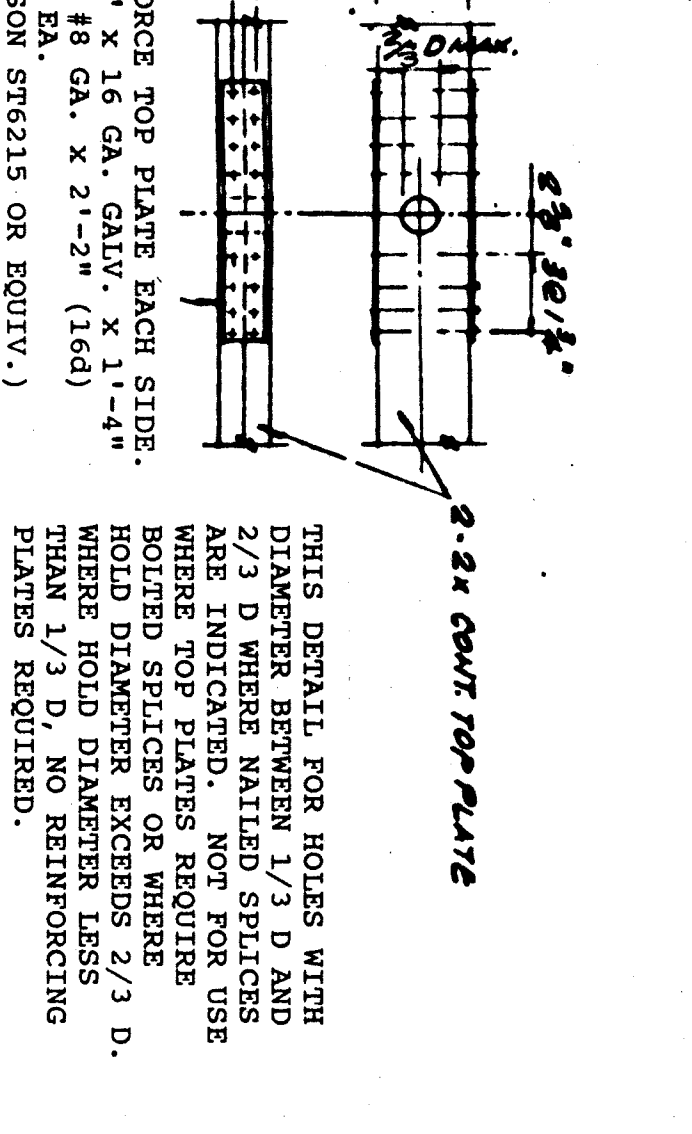
**TYPICAL PARTITION BRACING DETAIL**

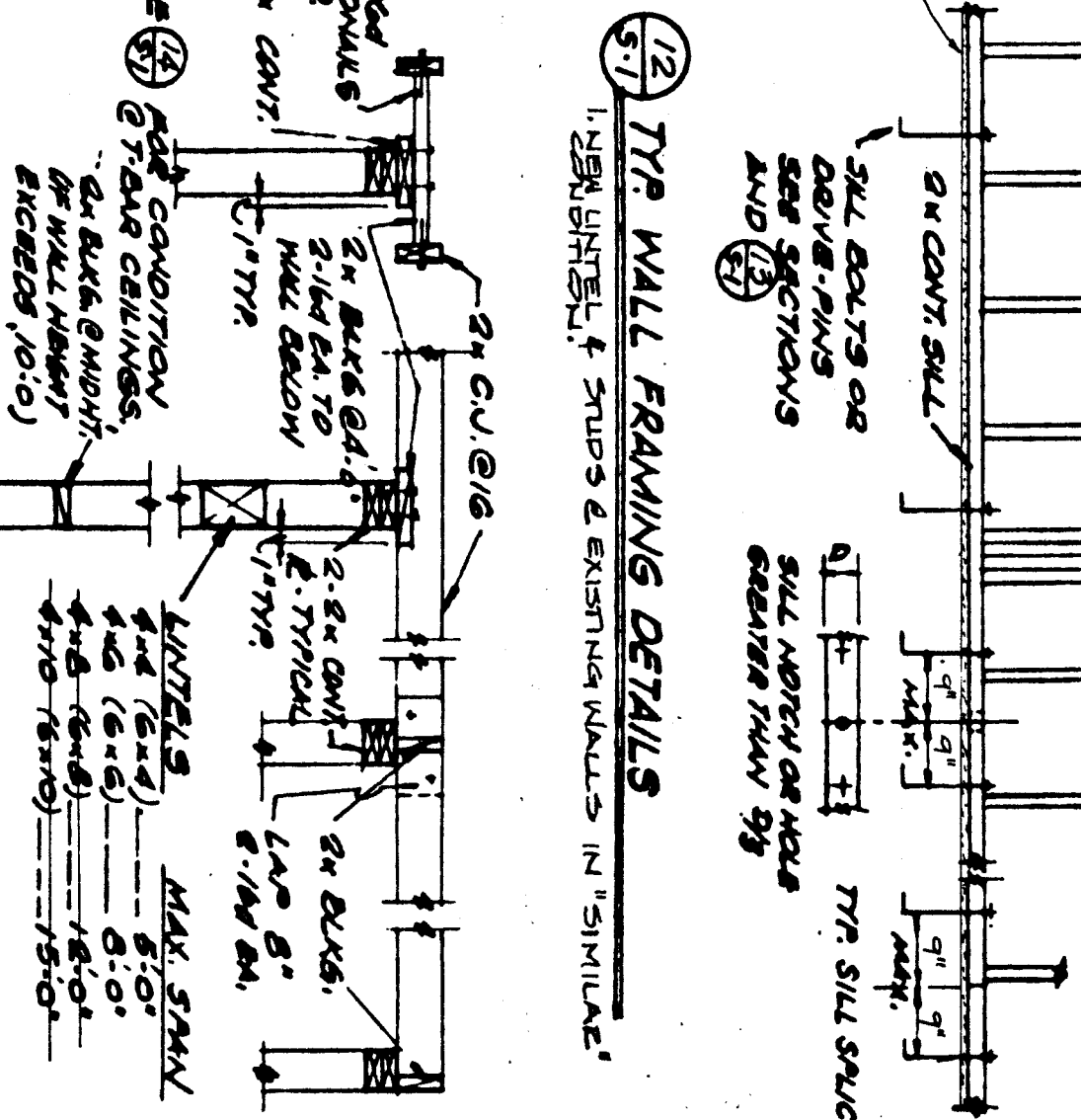

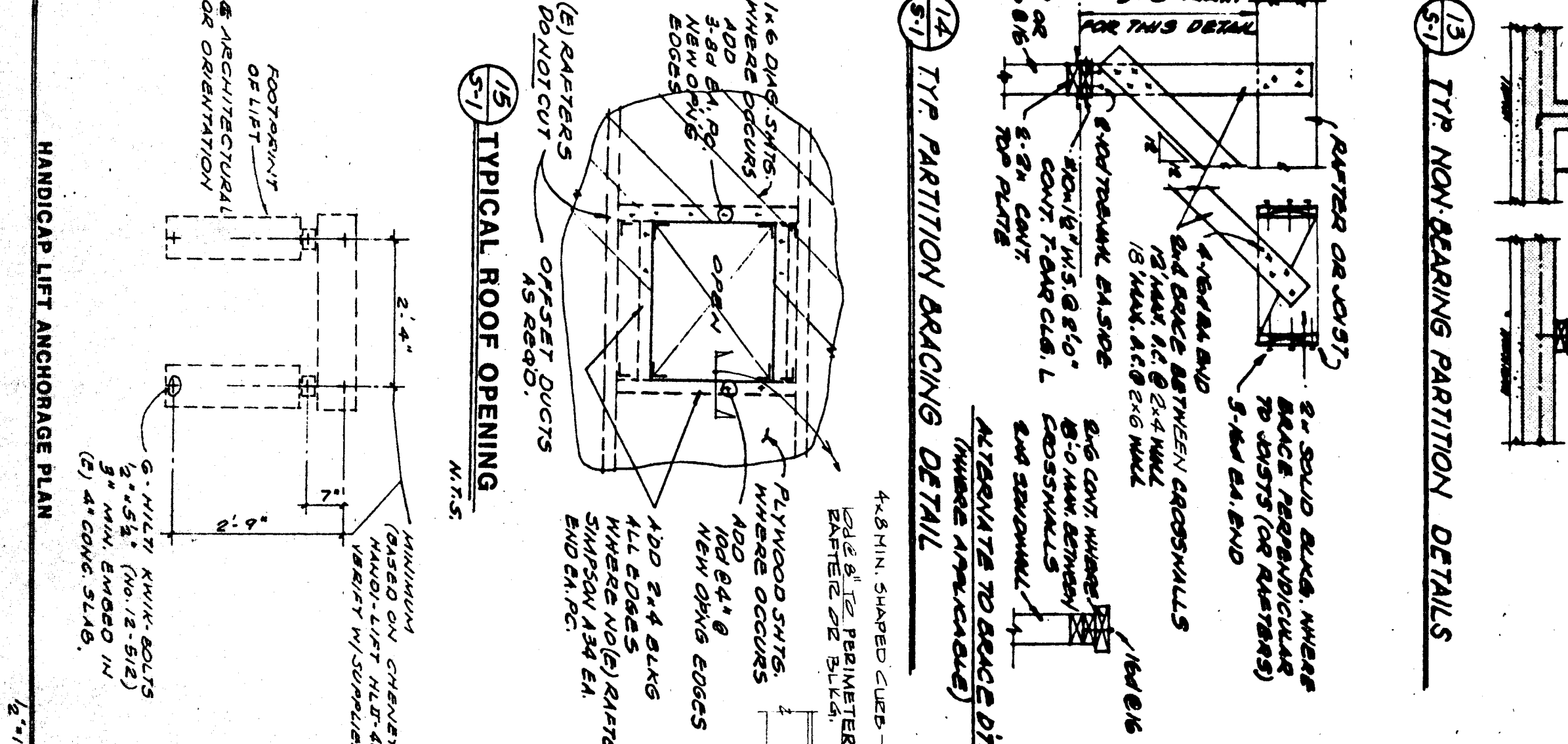
