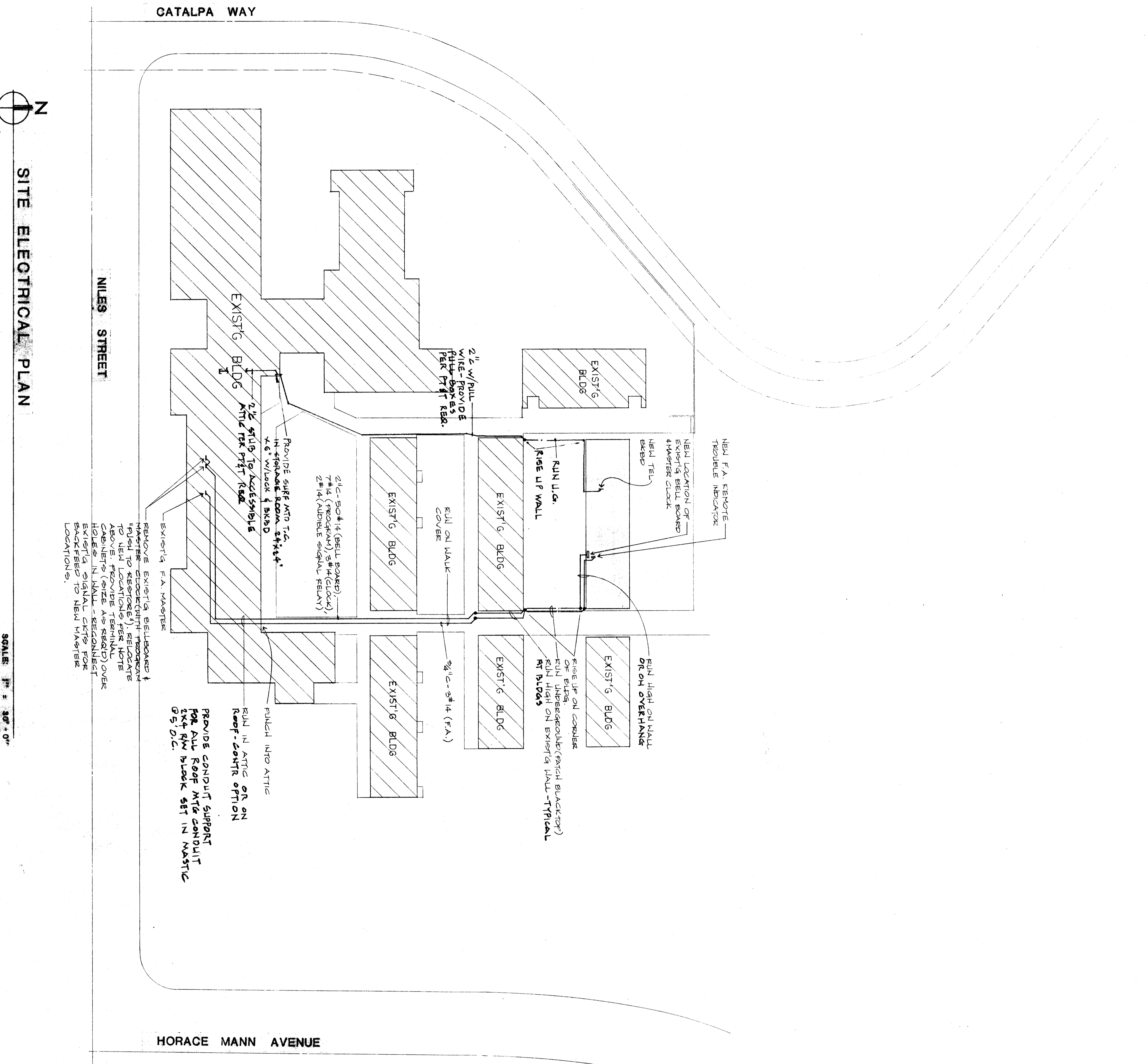

 1. 20% of Operating Weight
 2. 10% of Operating Weight
 3. 5% of Operating Weight
 4. 25% of Operating Weight
 5. 50% of Operating Weight
 6. 75% of Operating Weight
