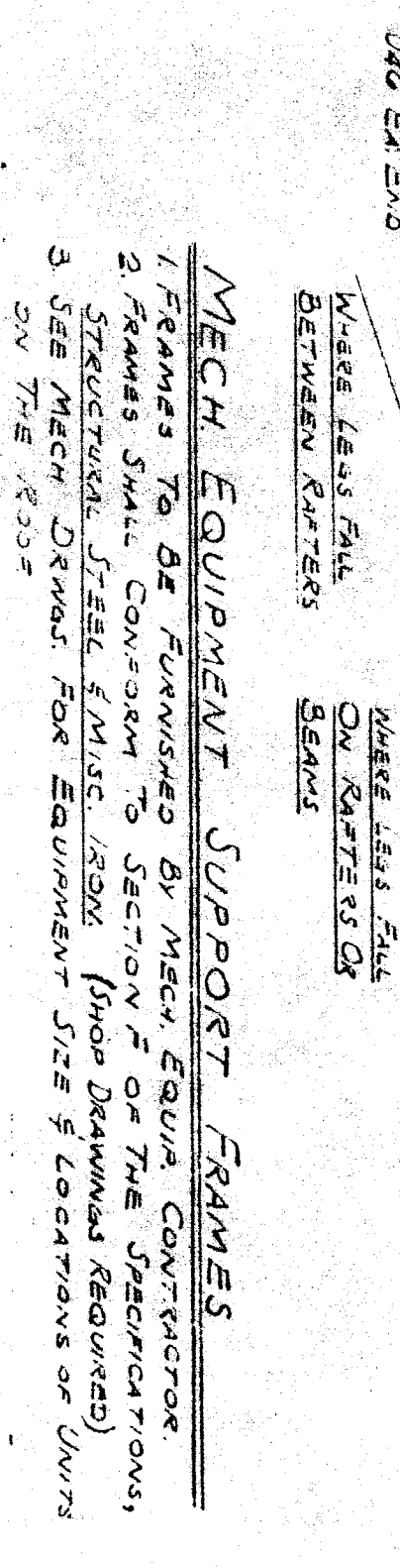

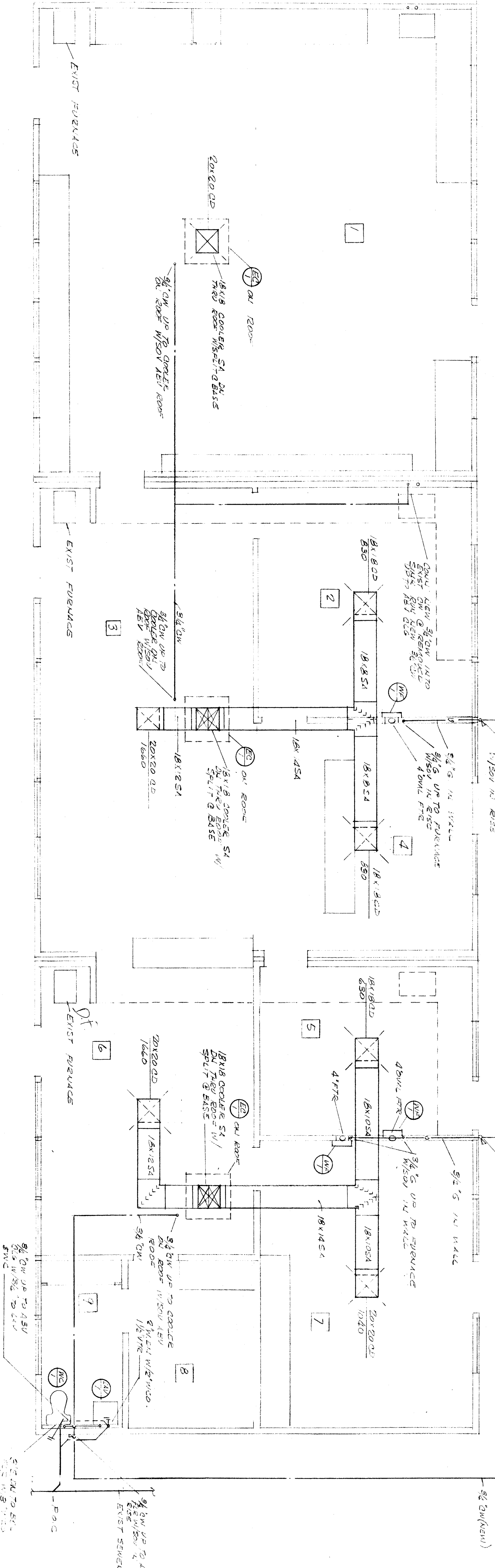

EQUIPMENT ANCHORAGE
 All mechanical equipment shall be braced or anchored to resist a horizontal force acting in any direction using:
 20% of Operating Weight
 30% of Operating Weight
 50% of Operating Weight
 75% of Operating Weight
 For Flexibly Mounted Equipment Use 2 X the above values.
 Simultaneous Vertical Force - Use 1/3 X Horizontal Force.
 Where anchorage details are not shown on the drawings the field installation shall be subject to the approval of the field representative of the State Architect.
